\_\_\_\_\_ 1. **The Humig-Wiebe Scholarship Fund**

**Established:** 1995

**Criteria:** To provide a scholarship to a student who has been accepted for enrollment and registered in an accredited institution of higher learning to pursue a course of study leading to a bachelor's degree or its equivalent, such person to be selected after giving consideration to character, dependability, academic accomplishment, and potential for future development and need.

\_\_\_\_\_ 2. **Popper Family Memorial Scholarship Fund**

**Established:** 1981

**Criteria:** To provide a scholarship award to a member of the senior class of Franklin County High School and its successor, who has been accepted for enrollment in an accredited institution of higher learning to pursue a course of study leading to a bachelor's degree or its equivalent, such person to be selected after giving consideration to character, dependability, academic accomplishment, and potential for future development and need.

\_\_\_\_\_ 3. **The Donald H. Wolber Scholarship**

**Established:** 1967

**Criteria:** To provide a scholarship award to a member of the senior class of Franklin County High School and its successor, who has been accepted for enrollment in an accredited institution of higher learning to pursue a course of study leading to a degree in aeronautical engineering or allied field. The recipient must have achieved academic excellence, high character, dependability, and physical fitness.

\_\_\_\_\_ 4. **John E. Lane Memorial Scholarship Fund**

**Established:** 1987

**Criteria:** To provide a graduating senior an award for academic excellence and extracurricular activities including organizations, clubs, music, and sports shall be made annually from the income of the fund.

- (1) A senior in good standing, active in extracurricular activities for a minimum of two (2) years.
- (2) Must have a minimum of "B" average during senior year.
- (3) Financial status will be taken into consideration.
- (4) Recipient must be an "all round" student chosen by a Scholarship Committee of the Brookville Foundation, which presently consists of principal of the high school, teacher sponsor of the National Honor Society or its successor, a teacher appointed by those two, and two persons appointed by the Board of Trustees of The Brookville Foundation.
- (5) Recipient must have applied to and been accepted by an accredited four-year college or university.
- (6) Scholarship is payable to the student upon satisfactory proof of his or her completion of first academic year; Second semester grades must be sent to The Brookville Foundation.
- (7) This scholarship is intended for application to sophomore year expenses, and will be paid to student upon his or her registration of sophomore year.

\_\_\_\_\_ 5. **James Runyon Memorial Scholarship Fund**

**Established:** 1992

**Criteria:** To provide a scholarship to a member of the senior class who has been accepted and has been enrolled in an accredited institution of higher learning.

The following factors shall be considered in choosing the recipient:

- (1) Financial need.
- (2) Preference shall be given to a student who has received his/her pre-high school education in Laurel Elementary School.

\_\_\_\_\_ 6. **The Jennifer Suzanne Brown Memorial Scholarship**

**Established:** 1997

**Criteria:** To provide a scholarship to a member of senior class who has been accepted for enrollment in an accredited institution of higher learning. The scholarship will be awarded to the person adjudged most likely to succeed and be effective in his/.her chosen field after giving consideration to academic accomplishment, character, dependability, and personality. A grade point average must be a "C" or above.

\_\_\_\_\_ 7. **Richard and Helen Maley Memorial Scholarship**

**Established:** 1999

**Criteria:** To provide a scholarship annually to a student from Franklin County who hopes to continue his/her education in an institute of higher learning. Consideration in awarding such scholarship would be given to a student who has elected to pursue a degree in nursing. The scholarship shall be awarded to the person adjudged most likely to succeed giving consideration to academic accomplishment, character, dependability, and personality.

\_\_\_\_\_ 8. **Saxon-Robbins Scholarship Fund**

**Established:** 2010

**Criteria:** To provide a scholarship to a qualified student who is pursuing a bachelor's degree in education at a duly accredited college or university.

The following factors shall be considered in choosing the recipient:

- (1) Be a graduate of St. Michael's in Brookville.
- (2) Be a male or female of high school academic and moral standards who has graduated from Franklin County High School.
- (3) Be accepted as a full time student in a duly accredited college or university pursuing a bachelor's degree in education.

\_\_\_\_\_ 9. **Lucille M. Ernst Scholarship Fund**

**Established:** 2013

**Criteria:** To provide a scholarship to a member of the senior class of Franklin County High School who has been accepted for enrollment for an accredited institution of higher learning to pursue a course of study leading to a degree in Elementary Education. The scholarship shall be awarded to the person adjudged most likely to succeed and be effective in the field of Elementary education, after giving consideration to character, dependability, accomplishment, potential for future development, and need.

\_\_\_\_\_10. **James R. Hughes Memorial Scholarship**

**Established:** 2019

**Criteria:** 1. To provide a scholarship to a member of the graduating senior class from Franklin County High School who has been accepted for enrollment in an accredited institution of higher learning to pursue a degree in Education. Consideration shall be given to character, dependability, academics accomplishments and the need of the applicant.

\_\_\_\_\_10. **James P. Mullin Scholarship**

**Established:** 2019

**Criteria:** 1. To provide a scholarship to a member of the graduating senior class from Franklin County High School who has demonstrated a commitment to service learning by having prior experience volunteering and participating in community service. Consideration shall be given to character, dependability, academics accomplishments and the need of the applicant.

### **James R. Kaffenberger Scholarship (by nomination only)**

The name of the scholarship to be awarded by THE BROOKVILLE FOUNDATION pursuant to this Agreement shall be the JAMES R. KAFFENBERGER SCHOLARSHIP.

Annually, commencing in the year 2004, and for so long as funds held pursuant to this Agreement are available, THE BROOKVILLE FOUNDATION shall provide an annual scholarship to a female student. Athlete graduating from FRANKLIN COUNTY HIGH SCHOOL, who for at least (1) year of the student's high school career has been involved in high school athletics. To qualify for consideration for the award of this scholarship from THE BROOKVILLE FOUNDATION, the female student/athlete shall be nominated by her High School Coach or the Director of the Franklin County High School, and the determination of the student selected to receive this scholarship shall be made from those nominees by THE BROOKVILLE FOUNDATION.

Additional criteria for the award of said scholarship shall be that said student/athlete must have demonstrated, through her high school career, a positive attitude and strong work ethic, and shall have demonstrated an aptitude to succeed academically at the college level. THE BROOKVILLE FOUNDATION, in awarding of the scholarship shall also consider the need of the student/athlete in that the scholarship is intended to help to make it possible for the selected student/athlete to attend college, and it is not intended that this scholarship be awarded to a female athlete who has earned a full room, board, and tuition scholarship to the college of her choosing on any other basis
